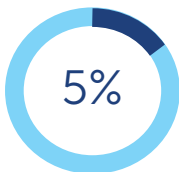

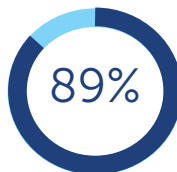

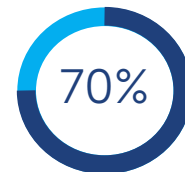

Businesses with high levels of automated controls have **70% lower error rates**.³

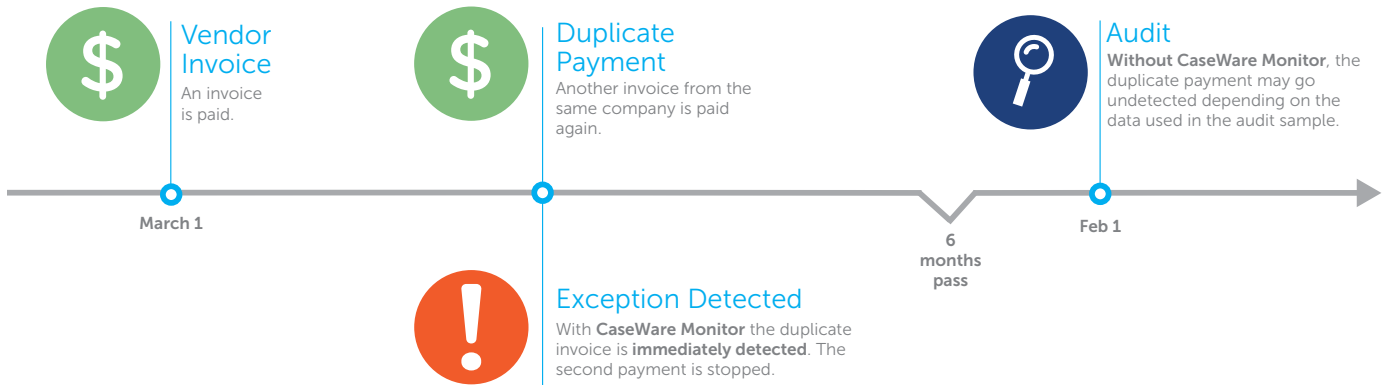

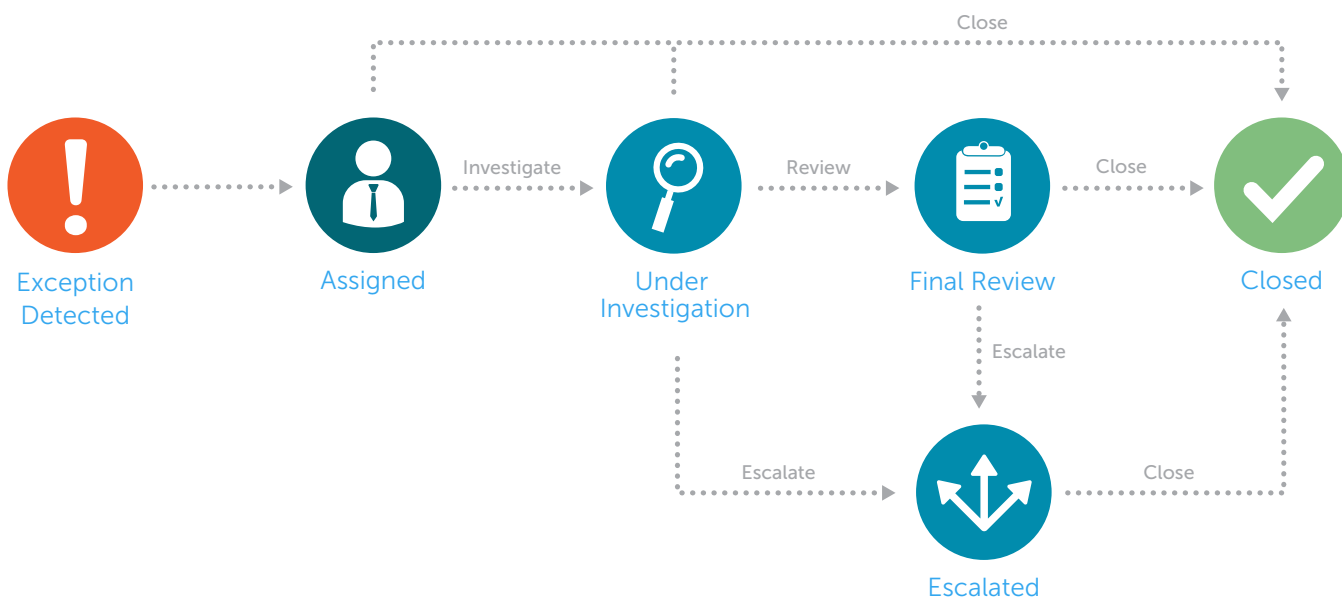
